Warranty Period: This One Year Manufacturer's Warranty covers the model SilverSaver1000 against defects in materials or workmanship from the date of purchase by the original purchaser for a period of one year.</p> <p>2. Service(s): If the product fails under normal use, FlatwareSaver LLC will repair or replace the defective part with a new or reconditioned replacement or reimburse the original purchaser the full purchase price of the unit at FlatwareSaver LLC's discretion. In the event of repair or replacement, the warranty will be equal to the remainder of the original limited warranty period on the original Product or for 30 days after the date of repair / replacement, whichever is longer. Unless otherwise authorized by FlatwareSaver LLC, all services must be performed by FlatwareSaver LLC or their agent. All replaced parts will be the property of FlatwareSaver LLC.</p> <p>3. Proof of purchase.
